ENTIRE AGREEMENT: This agreement constitutes a service of wedding portraiture services, as agreed to by both the Studio and Client.

PAYMENT: Accepted forms of payment include cash, check or US money order. Please make all checks payable to Corey Yost. A retainer of 50% of the package fee is required to hold the date of the event. The retainer is applied towards the reserving the date and is non-refundable. Final payment is due one month prior to the wedding.

DELIVERED GOODS: All-day wedding coverage constitutes up to twelve hours of photography. Proofs shall be available online 4 - 6 weeks after the event. Due to the photojournalistic nature of weddings, lists cannot be accepted and although the utmost care will be taken to capture moments throughout the day, specific image requests cannot be guaranteed. All photographs will be closely inspected by the Studio for correct exposure and artistic quality. Galleries will remain online for one year following the event.

PROVISIONS: Both photographers' meals shall be provided for at the reception. It is recommended that the photographers are served at the same time as the bridal party to guarantee important moments are not missed.

SOLE PHOTOGRAPHER: Similar images from the same wedding on two professionals' websites may raise concerns with authenticity, and it is therefore understood and agreed that no other professional photographers will be allowed to take pictures at the wedding while the Studio is working. A fine of \$500 will be incurred and no products will be released until the balance is paid in full should another professional studio cover the event.

CANCELLATION: Cancellation or change of date must be submitted in writing and both parties must sign a contract cancellation or contract change form provided by the Studio. The contract cancellation or change form will serve as legal abandonment of the original contractual agreements. If the Client should request a date change, they must do so at least 90 days prior to the initially scheduled event, in which case their retainer will be put toward their new date; if a date change is requested in less than 90 days prior to the event, a new retainer must be provided.

PERMITTED USES: Upon final payment by the Client, printing rights of the resulting images will be transferred to the Client for personal use. At no time will the Client assume images to be their own work. The Client must obtain written permission from the Studio prior to publishing the photographs commercially.

LIMIT OF LIABILITY: If the Studio cannot perform this agreement due to natural disaster, critical illness or injury, the Studio will return 100% of all fees to the Client but shall have no further liability with respect to this agreement.
